**Jemputan untuk memberi komen terhadap Penilaian Pengawasan Tahunan (ASA-04) ke atas Boustead Plantations Berhad (Nombor Keahlian RSPO: 1-0012-04-000-00), Unit Pengurusan Ladang – Boustead Estates Agency Sdn Bhd – Trong Business Unit, Taiping, Perak, Malaysia**

Pihak Berkepentingan yang dihormati,

Ini untuk memaklumkan bahawa Unit Pengurusan Ladang di bawah Syarikat Induk **Boustead Plantations Berhad** dengan nombor keahlian RSPO 1-0012-04-000-00 telah melantik Intertek Certification International Sdn Bhd untuk menjalankan ~~Audit Pengesanan / Pengesanan Semula/~~ **Audit Pengawasan Tahunan (ASA-04)** ke atas Boustead Estates Agency Sdn Bhd – Trong Business Unit yang terletak di Taiping, Perak. Pengauditan akan dilakukan dari **27 – 31 Julai 2026** dengan syarat:

- Malaysia National Interpretation (MYNI) 2019
- RSPO Principles and Criteria (P&C 2024) & RSPO Certification Systems (CS 2025)

Secara ringkas, Boustead Plantations Berhad ialah salah satu syarikat perladangan kelapa sawit hulu yang paling berpengalaman dan mapan di Malaysia dan anak syarikat Boustead Holdings Berhad ("BHB"), salah satu konglomerat terpelbagai tertua dan terbesar di Malaysia. Disokong oleh kehadiran BHB dalam perniagaan perladangan, mereka mempunyai lebih 100 tahun pengalaman industri perladangan dan lebih 50 tahun pengalaman pengurusan ladang ladang kelapa sawit. Mereka memiliki dan mengurus sejumlah 44 ladang kelapa sawit dan 10 kilang kelapa sawit di Malaysia dengan 18 ladang di Semenanjung Malaysia, 20 di Sabah dan 6 di Sarawak. Turut mengendalikan 3 kilang kelapa sawit di Semenanjung Malaysia, 5 di Sabah dan 2 di Sarawak. Jumlah simpanan tanah mereka berjumlah kira-kira 98,200 hektar (ha). Daripada jumlah ini, kawasan penanaman kelapa sawit adalah lebih kurang 73,500 hektar terdiri daripada 24,100 hektar di Semenanjung Malaysia, 39,100 hektar di Sabah dan 10,300 hektar di Sarawak.
