Ini untuk memaklumkan bahawa Unit Pengurusan Ladang di bawah Syarikat Induk FGV Holdings Berhad dengan nombor keahlian RSPO 1-0225-16-000-00 telah melantik Intertek Certification International Sdn Bhd untuk menjalankan ~~Audit Pengesahan / Audit Pengesahan Semula~~ / **Audit Pengawasan Tahunan (ASA-04)** ke atas Kilang Sawit Selancar 2B dan pangkalan bekalan /estet yang terletak di Segamat, Johor.
