Dear Stakeholders,

This is to inform that the above Management Unit under the Parent Company **IOI Corporation Berhad** with RSPO membership number **2-0002-04-000-00** had appointed Intertek Certification International Sdn Bhd to conduct the ~~Initial Certification/Recertification Audit~~ /Surveillance Audit (ASA-01) at **Mayvin POM** and its supply base, located at **Sandakan, Sabah**. The audit will be conducted from **7 – 11 September 2026** against the requirements of:

- Malaysia National Interpretation (MY-NI 2025)
- RSPO Principles & Criteria (P&C 2024)

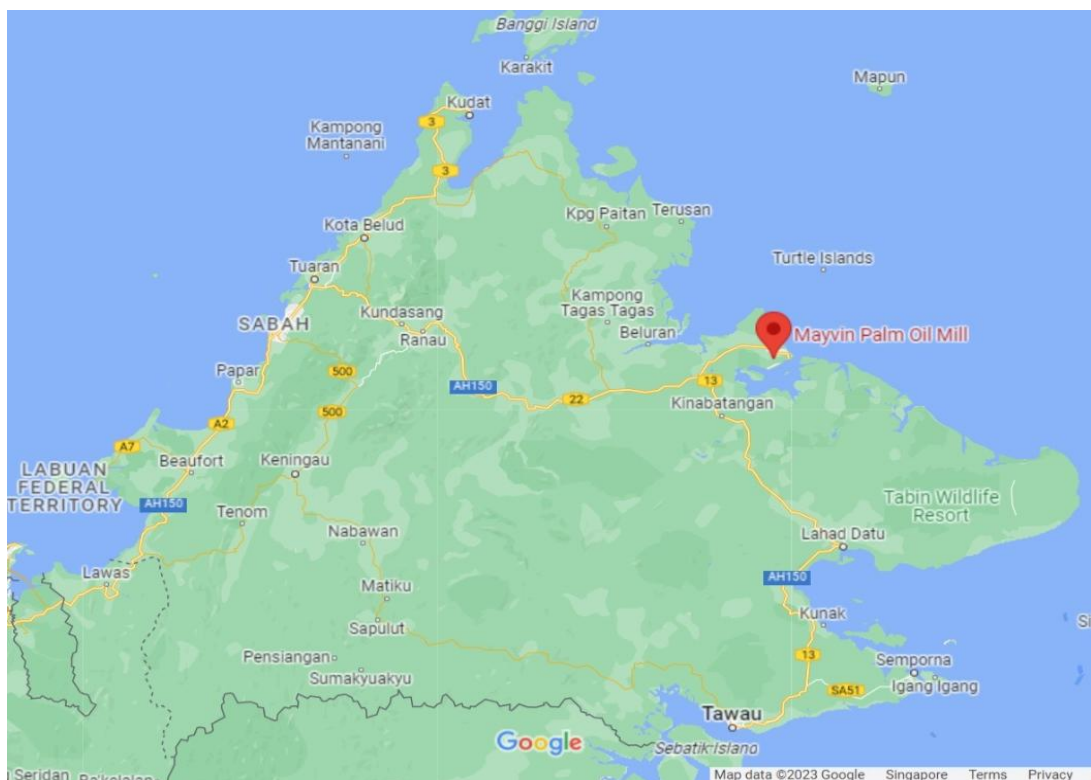
