Invitation to comment on MSPO Annual Surveillance Assessment (ASA-01) of Boustead Plantations Berhad Plantation Management Unit –Lepad Kabu Estate, Kuala Krai, Kelantan, Malaysia

Boustead Plantations Berhad has commissioned Intertek Certification International Sdn Bhd for the assessment and certification of its Plantation Management Unit, Lepad Kabu Estate against the requirement of the Malaysian Sustainable Palm Oil Standards series, MSPO 2530:2020-3.2 General principles for organised smallholder (above 500ha)

In ensuring that the organization continues to meet MSPO certification scheme requirements and in obtaining the feedback, Intertek Certification International Sdn Bhd would like to invite interested parties to comment on the audit of Boustead Plantations Berhad Plantation Management Unit –Lepad Kabu Estate. The certification unit are located at Kuala Krai, Kelantan, Malaysia.

In brief, Boustead Plantations Berhad is one of the most experienced and established upstream oil palm plantation company in Malaysia and a subsidiary of Boustead Holdings Berhad ("BHB"), one of Malaysia's oldest and largest diversified conglomerates.
