Purpose

To provide an overview of Intertek's process for handling requests for information related to Business Assurance activities

Scope

Intertek has a comprehensive process to handle requests for information. This process satisfies the requirements of both ISO/IEC 17021-1, 17065, and 17029.

Note

As per the requirements of above-referenced standards, information related to certified organizations and to organizations whose claim has been verified/validated, is confidential except for the confirmation of the certification status, the content of the certificate, and the content of the Verification/Validation Opinions.

Process

1. Any party may request information from Intertek via Email (directly or via the website), by phone or in writing/Email
2. Personnel receiving the request may, as appropriate, direct the requestor to the appropriate section(s) of Intertek's website or forward it to appropriate Intertek personnel.
3. In all cases Intertek shall ensure that the requestor is provided with the requested information, as long as it does not violate any confidentiality requirements and that such information is to be provided as per the requirements of the above referenced standards.

Types & Sources of Information

1. Information related to certified organizations and to organizations whose claim has been verified/validated:

Upon request, Intertek will confirm the status of a given certification, the information appearing on the certificate, the status of a given Verification/Validation Opinion and the information appearing on the Verification/Validation Opinion.
